

## **Rensportschool Zandvoort BV Waiver and Indemnity Declaration and Agreement to Participate at Your Own Risk**

*This Waiver and Indemnity Declaration must be completed and signed once annually After signing this form, you will receive a copy of the signature by email.*

### **APPLICATION**

This declaration and agreement apply to all events organized by RSZ in the calendar year 2024.

### **DEFINITIONS**

'RSZ' refers to Rensportschool Zandvoort BV and includes its properties, employees, instructors, and volunteers.

'Racing Circuits' include, but are not limited to, Circuit Zandvoort, TT Circuit Assen, Circuit Zolder (B), Circuit Jules Tacheny Mettet, RDW Lelystad, and Racepark Meppen (D), along with their properties, employees, (safety) marshals, and volunteers.

'Events' encompass all events organized by RSZ, including but not limited to RSZ Vrij Rijden Track Days, KNAF-recognized RSZ racing courses, Race & Tactics courses, Drift courses, Training Days, and circuit training, all of which take place at the Racing Circuits.

### **MOTOR SPORT IS DANGEROUS / PARTICIPATION AT YOUR OWN RISK**

As a participant, I declare that I am aware that driving or learning to race a car on a racetrack intended for this purpose is dangerous and is accompanied by an increased risk of material damage and/or physical injury. As a participant in the track days 2024 organized by RSZ, I accept such risks as my own, and I declare that costs (resulting from an accident) for the repair of material damage and/or physical injury are entirely at my own expense, regardless of the cause of the accident.

### **LIABILITY - WAIVER**

As a participant, I declare that I will not hold RSZ or the Racing Circuits liable for any physical or material damage of any nature and extent that occurred during my stay on the track and arose as a result of my participation during one of the track days organized by RSZ in the calendar year 2024, regardless of the cause.

### **CAUSING DAMAGE - INDEMNITY**

As a participant, I agree that I am responsible for my behavior and that of my accompanying visitor(s). I also declare that I will compensate the costs for the repair of physical and/or material damage caused or inflicted by me personally or by my accompanying visitors to RSZ or to the Racing Circuits, regardless of the cause.

### **FOLLOWING DIRECTIONS, FLAG SIGNALS, SOUND LIMIT, AND REGULATIONS**

As a participant, I agree to follow the instructions of RSZ and the Racing Circuits at all times. I also declare that I am familiar with all applicable flag signals, as well as the maximum noise limit applicable to the Racing Circuits.

### **EXCLUSION OF PARTICIPATION**

As a participant, I accept that RSZ has the right to exclude me from participation if I violate the applicable regulations or additional notices from RSZ or the Racing Circuits, if my car exceeds the applicable noise standard of the circuit one or more times, and if my (driving) behavior endangers others (intentionally or unintentionally). If I am excluded from participation, I accept as a participant that RSZ has no obligation to refund my registration fee and/or reimburse costs incurred by me.

### **PRIVACY DECLARATION**

As a participant, I declare that I consent to the use of my personal data under the condition that RSZ does not share it with third parties. I also declare that I consent to the use of photo or video material produced during the track days organized by RSZ, which is shown to promote RSZ or its suppliers or the Racing Circuits where I, as a participant, or the accompanying visitor(s), are visible.
